MDHHS Epidemic Order as it Relates to your **Real Estate Business**

- All persons participating in gatherings are required to wear a face mask.
- Mask Exception: At a residential gathering where all persons are fully vaccinated and not experiencing the principal symptoms of COVID-19.
- The limitation on residential gatherings remains at 15 persons from no more than 3 households.
- Open houses can be held; however, no more than three households (the listing agent and two prospective buyer households) can view the home at one time.

This order remains in effect through May 24th, 2021.

MichRIC[®] Watermark on Photos

You may have noticed recently, that photos added to the MLS, are no longer watermarked with the MichRIC[®] name. Over the course of several months the MichRIC[®] watermark will be removed from all photos in the MLS. These watermarks were previously added by default, when a user uploaded a photo to an MLS listing.

As a reminder, GKAR Rules and Regulations prohibits users from adding a watermark or logo to photos uploaded to the MLS. Please feel free to contact Sam Bartlett, at <u>SamB@gkar.com</u>, with any questions regarding watermarks.

New Fair Housing Policy

At the direction of your Board of Directors, the Potential Fair Housing Violation Identification Policy Task Force was created to review and implement policy regarding possible fair housing violations in the MLS.

The task force completed their review; their recommendations for new policy language and a fine was approved by the Board of Directors and has been added to GKAR *Rules and Regulations*.
