

## **Intel® Gaming Access Sweepstakes 05.03.2021**

### **ONLINE GIVEAWAY RULES**

#### **No Purchase Necessary—A Purchase or Payment Will Not Increase Your Chances of Winning**

##### **1. Eligibility**
