The Environmental Services Manager must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility.

The Environmental Services Manager executes company and facility environmental services programs and procedures by training, supervising and motivating the environmental services staff to ensure all tasks are completed and schedules are met. Scope of Service may include:
