<p><b>MRI Lead Technologist:</b> The MRI Lead Technologist must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility, as defined by facility job description.</p> <p><b>Definition of Care or Service:</b> The MRI Lead Technologist performs those functions necessary for the support, treatment, measurement or supplementation of the Imaging Services Department. The MRI Lead Technologist will demonstrate:

- Safe and effective operation of the applicable mobile equipment to maintain equipment in good working order
- Demonstrates effective infection control practices related to equipment operation
- Accurate patient information review and evaluation
  - Uses at least two ways to identify patients before treating or performing a procedure
  - Verifies that the pre-procedure process to verify the correct procedure, for the correct patient, at the correct site and involves the patient in the verification process when possible.
  - Accesses the patient medical record appropriately
  - Documents in the medical record according to the facility standard / policy
- Maintains a safe environment
- Infection Prevention
  - Practices consistent hand hygiene
  - Uses personal protective equipment (PPE) when required
  - Complies with Isolation precautions
  - Required immunizations per Division requirement
- Completes MRI Safety for Level II Personnel Health stream course.
- Follows facility screening procedures for contraindications with respect to drugs, contrast media and the presence of foreign bodies and implants which are not compatible with MR
  - Appropriately screen patients to identify contraindications which might preclude the execution of the examination
  - Ensures removal of contraindicated objects from the patient and from the attending individuals (attending individuals include other staff members or friends/family that have accompanied the patient)
  - Follow safety guidelines with respect to MR bio-effects and patients management
  - Observes and monitors the patient throughout the examination and administer first aid/basic life support in emergency situations
  - Provides procedure-specific patient education
- Infection Prevention
  - Practices consistent hand hygiene
  - Uses personal protective equipment (PPE) when required
  - Required immunizations per Division requirements
  - Complies with Isolation precautions
  - Maintains sterile field
