#### Wound Care Nurse:

The Wound Care Nurse must have equivalent qualifications and competence as employed individuals performing the same or similar services at the facility

#### Definition of Care or Service:

The Wound Care Nurse cares for patients with wounds caused by medical treatments, diseases, or injuries. They also provide post-surgery treatment and care for patients with ostomies. Scope of Service may include:

- Assesses patient in regards to self-care status and routines, knowledge level regarding ostomy/wound and problems related to ostomy/wound management.
- Develops care plan to address care needs relative to ostomy or urostomy diversion.
- Assists patient and/or staff with problem-solving as required.
- Assesses patient to determine type and volume of output, perifistular skin status, abdominal contours, and activity level.
- Assesses appliance care for containment of drainage and odor and protection of perifistular skin.
- Observes, evaluates and reports clinical findings to the supervising physician
- Documents these findings in the medical record
- Educates staff/caregivers regarding ostomy/wound management and provides follow up care as required.
- Complies with hospital and medical staff policy and procedures for accepting and documenting telephone orders from the supervising physician
  - Complies with hospital and medical staff policy and procedure specific to:
    - i. Restraints
    - ii. Do Not Resuscitate (DNR)
    - iii. High Alert Medications (Including chemotherapy)
    - iv. Investigational Drugs
- Demonstrates Clinical and Service excellence behaviors to include HCA Healthcare code of conduct core fundamentals in daily interactions with patients, families, co-workers and physicians
