Respiratory Therapist:

The Respiratory Therapist must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility, as defined by facility job description.

Definition of Care or Service:

The Respiratory Therapist is responsible for independently utilizing current respiratory care administration and monitoring practices in accordance with the physician's order. Scope of Service may include:

- Plans, organizes and conducts medically prescribed respiratory therapy programs for assigned patients following professional and Hospital required policies and procedures
- Helps patients reach maximum performance levels through therapy
- Sets up and operates various types of oxygen and other therapeutic gas and mist inhalation equipment
- Utilizes appropriately and rationally the available equipment as well as the related devices
- Responsible for the documentation of patient's evolution including evaluation reports on patient's progress, certifications and any other paperwork required by the area of service
- Evaluates records and other reports on patient's progress as required by the medical staff and the department Provides patient feedback to the involved staff on a timely and appropriate manner
- Establishes and maintains effective interpersonal relationships with the patient, work team, and all levels of the organization
- Reports incidents to supervisor and Risk Management department within required timeframe in accordance with medical center policy
- Complies with current Hospital security and safety polices
- Administers & Coordinates medical prescribed therapy as assigned
- Demonstrates Clinical and Service excellence behaviors to include code of HCA Healthcare conduct core fundamentals in daily interactions with patients, families, co-workers and physicians.
