Pre OP Nurse:

The Pre OP Nurse must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility, as defined by facility job description.

Definition of Care or Service:

The Pre OP Nurse evaluates the physical and mental health of patients who are coming into hospital for planned surgery.

Scope of service may include:

- Screens the patients' medical record for history and conditions
- Able to answer questions patients or family members have and verifies they're prepared for the surgery and for the after-effects of general anesthesia
- Evaluate and access admission documents
- Evaluate patient for testing, and discuss with surgeon prior to surgery
- Demonstrates effective communication and collaboration skills with members of the perioperative team and other stakeholders.
- Demonstrates Clinical and Service excellence behaviors to include code of HCA Healthcare conduct core fundamentals in daily interactions with patients, families, co-workers and physicians.

Setting(s):

• Surgical services areas including but not limited to hospitals and outpatient surgery centers

Supervision:

• Direct supervision by surgery department director, site manager or designee

Evaluator:

• Department director or designee in conjunction with supervising physician or licensed independent practitioner Surgery department director or designee with indirect from surgeon and anesthesia.
