Scope of Service may include:</p> <ul style="list-style-type: none"> Conduct assessments and evaluations to establish treatment goals and objectives Plan, implement, and evaluate treatment plans using counseling treatment interventions that may include counseling, assessment, consulting, and referral. Psychotherapy, either with individuals or groups. This does NOT include the prescribing of medications. Demonstrates Clinical and Service excellence behaviors to include code of HCA Healthcare conduct core fundamentals in daily interactions with patients, families, co-workers and physicians.

<p>State Requirements:</p> <ul style="list-style-type: none"> Current and active license in practicing state
<p>Experience:</p> <ul style="list-style-type: none"> At least 1 year experience as Licensed Professional Counselor
<p>Competencies: The Licensed Professional Counselor will demonstrate:</p> <ul style="list-style-type: none"> Knowledge of modern counseling practices and methods Knowledge of and adherence to existing professional ethical standards Ability to form and maintain effective counseling relationships with clients, to monitor client movement in the therapy process, and terminate the relationship in appropriate ways. Ability to plan, implements, evaluates, and report activities.
