<p><b>Non-Certified Autotransfusionist:</b> The Non-Certified Autotransfusionist must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility, as defined by facility job description.</p>
<p><b>Definition of Care or Service:</b> The Non-Certified Autotransfusionist is responsible for collecting shed blood from the patient during procedures, scrubs or cleans the blood of impurities, then makes it available to be reinfused into the patient. May also provide point of care blood gas and chemistry testing. Scope of Service may include:</p> <ul style="list-style-type: none"> <li>• Set up and operation of Autotransfusion device and/or bone marrow centrifuge device</li> <li>• Blood gas and blood chemistry monitoring/analysis/intervention</li> <li>• Plasma sequestration</li> <li>• Extracting out plasma &amp; re-suspending stem cells with red blood cells</li> <li>• Maintenance of equipment logs</li> <li>• Maintains and secures patient data and records</li> <li>• Clean and sterilize devices and equipment after use</li> <li>• Ensuring that items that will not be reused are disposed of correctly</li> <li>• Documents the procedure in the medical record</li> <li>• Demonstrates Clinical and Service excellence behaviors to include HCA Healthcare Code of Conduct; Relationship Centered Care principles.</li> </ul>
