Cryotherapy Technician:

The Cryotherapy Technician must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility, as defined by facility job description.

Definition of Care or Service:

The Cryotherapy Technician work with physicians and clinical staff to provide the mobilization and instruction for proper operation of Cryotherapy equipment. Scope of Service may include:

- Complete all administrative duties associated with the accurate billing and processing of paperwork
- Maintain aesthetic and operational parameters of all equipment and accessories
- Coordinate all inspections to assure all equipment is within manufacturer's inspection guidelines
- Demonstrates Clinical and Service excellence behaviors to include code of HCA Healthcare conduct core fundamentals in daily interactions with patients, families, co-workers and physicians.
- Providing technical support, as well as installing/repairing electrical/electronic equipment under the direction of manufacturers' technical support
- Mobilize & secure all equipment inside vehicle for transportation to/from facilities.
- Adhere to facility equipment check-in procedures.
- Maintain inventory of necessary accessories to complete procedures as planned.
- Follow reconciliation policies for assigned territory, including timely & accurate reporting.
- Facilitate accurate & legible documentation of each procedure to assure prompt & complete billing & collection for services using proper forms.
- Acquire authorized signatures & assists in processing of all required paperwork.
- Follow up with facilities & assist in the collection of services as directed.
- Assist lesser-experienced physicians with procedure or operation of equipment.
- Relate critical information to the physician based on training and experience of previous positive outcomes
- Be resourceful with on the spot trouble-shooting should equipment malfunction occur.
- Be prepared to work around radiologic equipment.
- Be able to direct several persons simultaneously while in the O.R.
- Be able to cross divisions of Cryo manufacturer service lines (Urologic and Interventional Radiology).
- Perform instructional in-services to facilities for first-time Cryo procedures when applicable.
- Demonstrates Clinical and Service excellence behaviors to include HCA Healthcare code of conduct core fundamentals in daily interactions with patients, families, co-workers and physicians

 - Documents in the medical record according to the facility standard/policy
- Achieve & maintain manufacturer/company training to operate Cryo equipment & associated accessories
- Handling & Cleaning of biohazardous materials/accessories
- Preparing & delivering information in a written form
- Preparing & delivering information orally in a formal & clinical setting
- Analyzing & developing solution to problems
- Reading/comprehending medical terminology
- Operating business machines (computers, keyboards, etc.)
- Knowledgeable of established routines around physicians and patients
