## **Childbirth Educator/Doula:**

The Childbirth Educator/Doula must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility.

## **Definition of Care or Service:**

The Childbirth Educator are instructors that teach classes to families expecting babies to help women and their families better understand the physical and emotional changes of pregnancy.

The Doula is trained in childbirth and provides emotional, physical, and educational support to a mother who are expecting, experiencing labor, or has recently given birth.

The Childbirth Educator/ Doula Scope of service may include:

- Educate women on having a safe, memorable, and empowering birthing experience
- Develops and implements health education programs designed to increase awareness and knowledge to patients planning to give birth
- Knowledge of reproductive health, pregnancy, childbirth, postpartum, breastfeeding, infant development, and infant care
- Keeps current on changes in labor and delivery technology to keep program material accurate
- Educate parents on the proper use of child passenger car seat
- Demonstrates Clinical and Service excellence behaviors to include HCA Healthcare code of conduct core fundamentals in daily interactions with patients, families, co-workers and physicians
- Provide the birthing woman with non-medical comfort techniques and alternatives for labor, including but not limited to positions and movement, comforting touch, visualization, breathing techniques, rebozo technique and affirmation.
- Provides emotional and physical support, suggests comfort measures, and provides support and suggestions for the partner.
- Refer to healthcare professionals when support requires clinical assessment, a need for prescription or medical diagnosis.
- Demonstrates Clinical and Service excellence behaviors to include HCA Healthcare code of conduct core fundamentals in daily interactions with patients, families, co-workers and physicians

The Doula is not a clinician and therefore **does not**:

- Diagnose medical conditions
- Perform clinical procedures
- Interpret medical diagnoses or clinical results
- Prescribe or administer treatment of medical conditions
- Perform clinical procedures
- Make decisions for the birthing woman
- Attend births that are intentionally unassisted by qualified medical professionals.
