<p>Definition of Care or Service: The Technical Specialist- LIS is responsible for maintaining database files on the Laboratory Information System and working with technical and programming personnel to coordinate implementation of test database information. The LIS Specialist has the experience needed to understand medical terminology and complex test build procedures, requiring independent judgment and minimal supervision.
