### **Certified Nursing Assistant-Hospice:**

The Certified Nursing Assistant-Hospice must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility.

#### Definition of Care or Service:

The Certified Nursing Assistant-Hospice work with terminally ill or dying patients to help ensure their comfort and quality of their remaining days, rather than working to cure or fix a patient. Hospice care is designed to help patients who no longer respond or want medical treatment to live out their final days in comfort, and prepare themselves and their families for their death.

Scope of Service may include:

- Performs tasks to maintain the department or area in an orderly and working condition
- Changes linens and cleans and stores the equipment after use
- Communicates all patient concerns as appropriate
- Establishes and maintains effective interpersonal relationships with the patient and the work team
- Assists in preparation of the unit and patient rooms for receiving admissions, transfers, and postoperative patients
- Uses proper body mechanics when positioning, lifting, turning, and ambulating patients
- Reports any changes observed in the condition or behavior of the patient to the assigned Registered Nurse
- Ensures patient personal and oral hygiene needs are met daily. Provides catheter care. Reports any pertinent observations to Registered Nurse.
- Accurately takes vital signs and records in patient record promptly.
- Records correct stool samples taken within shift as well as delivers each sample to the lab promptly.
- Provides posts-mortem care including labeling and securing all patient valuables
- Demonstrates Clinical and Service excellence behaviors to include code of HCA Healthcare conduct core fundamentals in daily interactions with patients, families, co-workers and physicians.
