Licensed Master Social Worker (LMSW):

The Licensed Master Social Worker (LMSW) must have equivalent qualifications and competence as employed individuals performing the same or similar services at the facility.

Definition of Care or Service:

The role of the Licensed Master Social Worker (LMSW) is to provide the special skills and knowledge of a Social Worker in the context of mental health therapy for their clients.

Scope of Service may include:

- Psychosocial assessments, crisis intervention and supportive counseling
- Advocacy and protective work-whenever there are issues of abuse, neglect, or violence
- Develop and maintain patient case records, plans and reports; compile data for statistical purposes
- Community outreach-referral and coordinating services
- Performing research tasks within a clinical setting
- Consulting physicians-general practitioners and specialists
- Demonstrates clinical and service excellence behaviors to include HCA Healthcare code of conduct core fundamentals in daily interactions with patients, families, co-workers and physicians

• Healthcare facilities including but not limited to hospitals or outpatient treatment facilities

Supervision:

• Direct supervision by the Director of Case Management or Licensed Clinical Social Worker

Evaluator:

• Department director of Case Management or designee
