<p><b>Certified Dialysis Technologist:</b> The Certified Dialysis Tech must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility, as defined by facility job description.</p> <p><b>Definition of Care or Service:</b> The Certified Dialysis Tech assists RN with patient care by performing hemodialysis, peritoneal dialysis, aphaeresis, CRRT, and Ultra-filtration procedures ordered by a physician.
