Scope of service may include:</p> <ul style="list-style-type: none"> • Coordinate with doctors, nurses and other medical professionals to take patients from their rooms to various locations for X-rays, scans, surgery and other medical tests or procedures. • Collect and deliver laboratory specimens to technicians, move medical equipment, wheelchairs and stretchers • Ensuring adequate and appropriate volume of inventory • Updates logs and documents the delivery of stock to storage locations, preparing product for shipping, restocking inventory, counting par levels, • Rotating stock to ensure no items are out dated, documenting the receiving and deliveries of supplies and equipment. • Performs cycle counting and physical inventory counts are completed as required by Departmental policy. • Keep receiving areas, warehouse shelves and aisles clean, organized and free of hazards and obstructions. • Maintains material handling equipment and reports any potential problems. Handles supply situations in an accurately and timely manner. • Demonstrates Clinical and Service excellence behaviors to include code of HCA Healthcare conduct core fundamentals in daily interactions with patients, families, co-workers and physicians.
