<p>Mental Health Assessor: The Mental Health Assessor must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility, as defined by facility job description.</p>
<p>Definition of Care or Service: The Mental Health Assessor assists the behavioral health team with assessments in order to determine any problems, strengths, needs, abilities and preferences that the patient requires. This information should help support the determination of a differential diagnosis and assist in screening for/ruling-out potential co-occurring disorders. Scope of Service may include:</p> <ul style="list-style-type: none"> • Facilitates the patient's access to the appropriate level of care and setting • Consults with admissions department, CNO, and CEO about the acceptability of admissions • Maintains equipment and records • Assesses need for involuntary hospitalization evaluation and contacts county crisis team, law enforcement etc. as needed to ensure the safety of patient and others. • Prepares written report of assessment results in a timely manner (immediately following completed assessment) and includes recommendations for the level of care and treatment needs. • Performs quality assurance activities related to the behavioral health assessment and disposition process • Demonstrates Clinical and Service excellence behaviors to include code of HCA Healthcare conduct core fundamentals in daily interactions with patients, families, co-workers and physicians

At least 1 year of behavioral health counseling, or experience in related field and evidence of continuing professional development preferred

Competencies:

The Mental Health Assessor will demonstrate:

- Provides assessment, de-escalation, psychoeducation and crisis intervention in the ED.
- Supports family members, and enlists family involvement as appropriate in assessing and resolving the crisis.
- Provides resources to individuals as needed to help resolve crisis, i.e. housing, food bank, and outpatient medical and mental health care.
- Provides follow up check in by phone or in person after a crisis intervention as appropriate.
- Provides assessments to determine the least restrictive setting appropriate to maintain client, family and community safety.
- Facilitates approval for appropriate level of care from insurance as needed.
- Follows principles of trauma-informed care to avoid harm and re-traumatization of the client and family.
- Participates in supervision and training as directed.
- Works cooperatively with all staff to ensure a smooth disposition to the most appropriate level of care.
- Ensures that clinical documentation is completed promptly and correctly.
- Provides on-site consultation with other ED staff as requested.
- Intends to provide patient care, treatment or services.
- Demonstrates proficiency in using psychological tests
- Maintains confidentiality and privacy in accordance with HIPAA regulations
- Accurate patient information review and evaluation
 - Uses at least two ways to identify patients
 - Verifies that the requested services correlates with the patient's clinical history, presentation and physician order accesses patient's medical record appropriately
- Infection Prevention
 - Practices consistent hand hygiene
 - Uses personal protective equipment (PPE)
 - Required immunizations per Division requirements
 - Complies with Isolation precautions
 - Maintains sterile field
