# **ABOUT MEHARRY MEDICAL COLLEGE**

Located in Nashville, Tennessee, Meharry Medical College was founded in 1876, just 11 years after the end of the Civil War. The initial mission of the College was to educate African-Americans to serve the health care needs of recently freed slaves beset with desperate medical conditions. Today, Meharry includes a School of Medicine, School of Dentistry, School of Applied Computational Sciences, and a School of Graduate Studies Research and is home to the Center for Health Policy at Meharry and the Lloyd C. Elam Mental Health Center. Degrees conferred by Meharry include Doctor of Medicine (M.D.), Doctor of Dental Surgery (D.D.S.), Doctor of Philosophy (Ph.D.), Master of Science in Public Health (MSPH), Master of Health Sciences (MHS), Master of Science in Data Science (MSDS), and Master of Science in Biomedical Data Science (MSBDS). The College also awards a Certificate in Health Policy.

As the nation's largest private, independent, historically black academic health sciences center, the College has trained over 40 percent of America's African-American dentists and has produced a significant component (8 percent) of the nation's African-American physicians. Currently, 17 percent of African-Americans holding Ph.Ds. in the biomedical sciences are Meharry graduates. Providing opportunities for people of color, individuals from disadvantaged backgrounds and all others— regardless of race or ethnicity—is central to the Meharry mission.

Today, under the leadership of Dr. James E.K. Hildreth, the College is experiencing groundbreaking change, strong initiatives both domestically and internationally, sound development within the three schools of study and substantial support from alumni and friends.

## ABOUT THE ASSOCIATE VICE PRESIDENT, INSTITUTIONAL ADVANCEMENT

Along with the Senior Vice President, Institutional Advancement and Chief Strategy Officer, the Associate Vice President is the most senior development officer within Institutional Advancement. They are responsible for all fundraising, including major and planned giving, annual giving, corporate and foundation relations, stewardship, prospect research, and the operations that support fundraising activities. Institutional Advancement is currently a team of 13, five of whom report directly to the Associate Vice President.

The Associate Vice President will also serve as the Campaign Director for Campaign 150, the College's \$200 million capital campaign, which is scheduled to close in 2026, the 150th anniversary of Meharry. The public phase of the campaign was announced in April 2021, and to date, close to \$100 million has been raised.

The Associate Vice President will carry and cultivate a small portfolio of leadership giving prospects. The primary focus of the Associate Vice President is to develop fundraising plans and establish a sound infrastructure for the Institutional Advancement team. They will also develop





metrics to evaluate the performance of individual gift officers and the entire Institutional Advancement team. Additionally, they will build on and expand Meharry's culture of philanthropy and develop the capacity of Institutional Advancement. With the Senior Vice President, this advancement leader will advise on fundraising strategies for the College, including the capital campaign.

# **MAJOR OBJECTIVES**

Within the first 12 to 18 months, the Associate Vice President, Institutional Advancement will achieve the following major objectives:

- Build a robust Institutional Advancement team that includes direct calling officers as well as advancement operations. This will include evaluating the team's current capacity and making the necessary adjustments that will help to ensure high performance. Additionally, the Associate Vice President will optimize Institutional Advancement's organizational structure and establish aspirational yet attainable goals for each team member.
- Serve as the Director of *Campaign 150* and ensure that Meharry meets or exceeds its campaign targets and timelines. As the Campaign Director, the Associate Vice President will work closely with the Senior Vice President, Institutional Advancement and Chief Strategy Officer on the progress and direction of Meharry's capital campaign.

# **RESPONSIBILITIES**

The Associate Vice President, Institutional Advancement will have the following primary responsibilities:

- Provide guidance and strategic direction for Institutional Advancement, including structure, staffing, goals, and professional development.
- Serve as the Director of *Campaign 150*.
- Oversee the planning and implementation of all programs and activities designed to enhance philanthropic support of the College by helping to establish goals for all units, and by directing the strategic implementation and assessment of fundraising and engagement strategies to achieve those goals.
- Manage the cultivation, solicitation, and stewardship of a small portfolio of leadership gift prospects through personal visits and other forms of communication.
- Plan and support all fundraising and constituent activities of the Associate Deans. Where necessary, the Associate Vice President will serve as a proxy for the Senior Vice President.





- Work with the Chair of the Board of Trustees and other leaders on the Board to ensure coordination and continued progress of all fundraising and constituent engagement activities.
- Directly manage five professional staff members who have responsibility for annual giving, major and planned giving, corporate and foundation relations, stewardship, prospect research, and advancement operations.
- Represent the College at events, to volunteer groups, and in the community with the goal of increasing the visibility of Meharry's advancement priorities and needs.

# **QUALIFICATIONS**

The ideal Associate Vice President, Institutional Advancement will bring most of the following qualifications and skill sets:

- Seven to ten years of progressive advancement leadership.
- Demonstrated experience as a successful fundraiser in a complex and dynamic environment such as a higher education institution, healthcare and hospital system, or voluntary health association.
- Previous capital campaign experience, ideally in a higher education institution.
- The ability to help determine the fundraising priorities of Meharry Medical College.
- A collaborative and inspiring approach that is supported by data-centered rigor and a strong emphasis on accountability.
- Creative and entrepreneurial thinking.
- Leadership presence that is effective with a variety of constituencies, including trustees, faculty, senior administration, and high-level volunteers.
- Authentic appreciation for the role that Meharry Medical College plays as a premier medical college and a Historically Black College and University institution.
- The ability to travel 30% with advancement team members.
- A Bachelor's degree is required. A Master's degree or an equivalent combination of education and experience would be an advantage.

## **COMPENSATION AND BENEFITS**

The salary range for this position is competitive. The Associate Vice President, Institutional Advancement will need to live in Nashville, Tennessee. Staff is currently working remotely due to COVID-19. Benefits include medical, dental, and vision insurance; life insurance; short- and





long-term disability; 401(k) program with employer match; paid time off including holidays, sick days, personal days, and vacation.
