15. Drive and foster an ecosystem of innovation, digitalisation, and entrepreneurship to ensure continued and sustained business success.


DMCC will communicate the Sustainability Policy Statement to all its employees and ensure it is freely available to the wider community. This policy will be reviewed and updated as required.
