Course Formats:

Self-Study – Self-study courses are online, self-paced learning experiences that can be completed at your convenience. Includes pre-recorded video lectures, interviews, text, case studies, interactions, knowledge checks and assignments.

Facilitated – Facilitated courses are online synchronous and asynchronous, faculty-led learning experiences that last four weeks and encourage collaboration with classmates. Includes webinars, pre-recorded lectures, text, asynchronous discussion, and assignments.

Live – Live courses are offered in-person, at AAPL institutes, where attendees receive face-to-face instruction from expert faculty members and is designed to be an interactive and engaging experience.

Eligibility

To be eligible for the CPE Capstone, candidates must meet the following criteria:

- Be a **licensed** M.D. or D.O.
- Have at least one cumulative year of significant health care **leadership experience** and managerial oversight as described in the Capstone leadership criteria.
- Be (or have been) **board certified** in a clinical specialty recognized by the ABMS or AOA, OR a recognized international equivalent.
- Three years' experience in **clinical practice** beyond residency and fellowship training.
- Complete the **Certified Physician Executive curriculum** OR have a qualifying graduate management degree. (*MBA, MMM, MHA, MPH, MS-HQSM, MS in management, etc.*)
- Once you meet all eligibility requirements, you would **apply online** for the CPE Capstone. The Capstone is a live 3 ½ day certifying program and is the final step in achieving the CPE credential. We offer the Capstone four times a year.
