

## **Privacy Policy**

This Privacy Policy describes Presagia's current policies and practices with regard to personal data collected through its websites. The term "personal data" refers to personally identifiable information including name, title, telephone number, email address and mailing address. If you are accessing our websites on behalf of a business or organization, that business or organization accepts the terms of this Privacy Policy.

### **Personal Data Collected**

Other than cookies, as described below, the only personal data Presagia currently collects through its websites is the information you voluntarily provide to us when you use one of our sites. For example, you may use one of our websites to contact Presagia with questions and comments about our products. When you fill out a form, you may provide your name and other contact information, including your company's name, telephone number and your email address. If you do not wish to fill out all of the information on the form, you are not required to do so. When you submit information to us through one of our websites, you will usually receive a confirmation email if you enter a valid email address.

### **Use of Personal Data**

Presagia uses the information you provide to answer your questions or resolve your problems. Presagia also uses this information to help us improve the content and functionality of our websites, to better understand our customers and markets, and to improve our products and services. Presagia may use this information to contact you in the future to tell you about products or services we believe will be of interest to you. If we do so, each communication we send to you will contain instructions permitting you to "opt-out" of receiving future communications. If you submit feedback or suggestions, we may use your feedback or suggestions without obligation to you or to your organization.

### **Anonymous Data**

In addition to the information you provide when you use one of our websites, Presagia uses technology to collect anonymous information about the use of our website. For example, we use technology to track how many visitors access our website, the date and time of their visit, the length of their stay, and which pages they view. We also use technology to determine which web browsers our visitors use and the address from which they accessed our sites (for example, if they connected to a Presagia website by clicking on one of our ads). This technology does not identify you personally. Presagia uses this anonymous data to improve the content and functionality of our websites, to better understand our customers and markets, and to improve our products and services.

### **Disclosure of Your Personal Data**

Presagia may share some of the data collected through our website with third-party vendors who act for or on behalf of Presagia or our affiliates (for example, companies that help us market our products and services). These companies are not authorized to use the information we share with them for any

other purpose. In addition, there may be some other, limited circumstances in which Presagia may share data, for example, to comply with a legal requirement or in the event of a corporate sale, merger, reorganization, dissolution, or similar event.

### **Cookies**

A cookie is a small piece of information that is sent to your browser and stored on your computer's hard drive. Cookies do not damage your computer and they cannot be used to discover the identity of a user. You can set your browser to notify you when you receive a cookie. This enables you to decide if you want to accept it or not. Presagia may use cookies to "persist" a user session — that is, to maintain connection with a user as he or she moves through a series of web pages. The purpose of cookies in this context is to remember user inputs. For example, a "shopping cart" application may record purchases in a cookie up until the time the user completes their checkout.

### **Links to Other Sites**

Presagia's websites may contain links to other websites that are not operated by Presagia. These links are provided for your reference and convenience only and do not imply any endorsement of the activities of these third-party websites or any association with their operators. Presagia does not control these websites and is not responsible for their data practices.
