Training Pedagogy

Pedagogy and construction are just as important as content to ensure the greatest efficacy of training material. The adult learning specialists on Intertek Alchemy's team incorporate many proven best practices from learning scientists, including:

- Micro learning bursts each course is broken down into individual concepts with short durations that are strategically stitched together
- Scenario and story-based structures are utilized to retain engagement
- Adherence to effective image-to-word-count ratios
- "Active learning" principles requiring learner participation at frequent intervals
- Repetition and reinforcement strategies on key concepts to ensure learner retains knowledge

Scheduled Reviews

At times Intertek Alchemy will conduct an ad hoc review of specific courses prior to the regularly scheduled review date. Reasons for doing so can include:

- Changes to industry certification schemes or requirements

A typical courseware review includes a robust analysis of the content in all applicable languages, data from questions and answers, client feedback, and changes to regulation and industry processes since the last review or course update. Updates identified during this review are vetted with our Intertek Alchemy Content Expertise Board during the update process prior to publication. Release notes that outline changes to content are published and available to our clients.
