



#### SUGGESTED FORMULA

Clotrimazole 2% / Ibuprofen 2% / Metronidazole 1% / Nifedipine 0.2% / Dexpanthenol 3% Ointment

Version number: 1.0

Volume or quantity: 100g

Clotrimazole, USP (CL127)	2 g
Ibuprofen, USP (IB100)	2 g
Metronidazole, USP (M1511)	1g
Nifedipine, Micronized, USP (NI133)	0.2 g
Dexpanthenol, USP (P1831)	3 g
Aquaphor or anhydrous base	90.8 g

#### SUGGESTED COMPOUNDING PROCEDURES

1. Calculate the quantity of each ingredient for the amount to be prepared.
2. Accurately weigh all ingredients.
3. Reduce the powder to a relatively uniform particle size and mix together.
4. Incorporate the Aquaphor or anhydrous base geometrically, with thorough mixing after each addition.
5. Package and label.
6. Suggested quality assessments.
  - a. color and texture
  - b. appearance, feel, melting
  - c. Label - auxiliary labels, storage, BUD, compounded medication

Store in air-tight container, at Controlled room temperature away from heat.
