

SUGGESTED FORMULA

Tadalafil 20 mg / Testosterone 10mg Sublingual Troche Version number: 1.0

Volume or quantity: 30 Troches

Tadalafil, USP (T1617)	0.6g
Testosterone Micronized, USP	0.3g
Colloidal Silicon Dioxide, NF, EP (S1510)	0.3g
Stevioside (S1964)	1.0g
Acacia, NF	0.5g
Polyethylene Glycol 1450 MW, NF (P1492)	28.11g

SUGGESTED COMPOUNDING PROCEDURES:

The quantity of PEG 1450 may need to be altered depending upon the size of the molds used. Calibrate Troche Mold and adjust formula as needed. This formula is based on approximately 1 g per troche. It is desirable to calculate for approximately 10% overage of the ingredients to adjust for excess materials required.

SUGGESTED MIXING INSTRUCTIONS:

- 1. Calculate the required quantity of each ingredient for the total amount to be prepared
- 2. Accurately weigh and/or measure each ingredient
- 3. Heat the PEG 1450 until melted in a beaker to about 55°C
- 4. Triturate the Tadalafil, Testosterone, Acacia and Stevia to a fine powder in a glass mortar and pestle
- 5. Add the fine powder mixture to the heated PEG 1450 and mix well
- 6. Pour into molds and allow to cool
- 7. Package and Label; Refrigerate
- 8. Suggested Quality assessments:
 - a. color, texture, appearance
 - b. troche cavity filled / not overfilled
 - c. mixing and filling/potency studies
 - d. Label auxiliary labels, storage, BUD, compounded medication

Store in air-tight, light resistant container, refrigerated.
