Zinc Gluconate 92.5mg Troche  
(13.2 mg Elemental Zinc)  
Version number: 1.0  
Volume or quantity: 35 Troches

Zinc Gluconate, USP (Z1077)	3.237 gm
Glycine, USP (AM125)	5.337 gm
Flavoring (optional)	q.s.
Techna 20 SF Troche Base w/Bitter-Bloc (550-83338)	36 gm
Smart-Scripps 30 Cavity Troche Molds (550-83014)	1 mold

### **Zinc Gluconate 7mg is approximately equal to Zinc Elemental 1mg.**

The density of the dosage form will be different when varying amounts of active pharmaceutical ingredients are used. This formulation is based on a calibration of 1.2 gm of Techna 20 SF Troche Base per cavity.

### SUGGESTED COMPOUNDING PROCEDURES

1. Calculate the required quantity of each ingredient for the total amount to be prepared
2. Accurately weigh and/or measure each ingredient
3. Melt the Techna 20 SF Troche Base at 45-55°C. Do not overheat
4. Pass the powders through a 40 Mesh sieve onto a glassine sheet
5. Once the Base reaches a working temperature appropriate for the active (s) used, sprinkle powders into the melted base, prevent clumping and ensuring addition is wetted before adding additional powder while maintain a good workable temperature
6. Once the powder mixture has been added incorporate the flavor and mix well
7. Pour into molds, quickly filling each cavity
8. Set time should be 5-10 minutes
9. Suggested Quality assessments:
  - a. color, texture, appearance
  - b. troche cavity filled / not overfilled
  - c. mixing and filling/potency studies
  - d. Label - auxiliary labels, storage, BUD, compounded medication

Store in air-tight container, at Controlled room temperature.
