

Systemic Racism as the Culprit

- The pandemic has clearly exposed the systemic racism that has generated the devastation on Latinos and other people of color
- A confluence of racial inequities
 - Significantly higher infection and death rates from COVID-19 than whites
 - The loss of jobs and the lack of recovery
 - The lack of medical insurance
 - Essential workers on the front lines
 - Crowded living conditions
 - Unauthorized immigrants left to fend for themselves
- There is no urgency to control the coronavirus and COVID-19 when it is Latinos and other people of color who are disproportionately dying








COVID-19 Impacts on Housing

- Renter households more vulnerable to COVID-related financial hardship (job loss)
 - In CA over 1 Mil renter households; 75% include at lease one person of color in the household
- Black and Latinx households are more likely to be rent burdened and miss rent payments.

COVID-19 Impacts on Small Businesses

- 4.1 Mil small businesses in CA
- 1.2 million self-employed minorities
- Active businesses owned by Latinx dropped by 32% and immigrants by 36%.
- Unique Challenges
 - Layoffs and furloughs
 - Guidance Diverse Sectors
 - Information, Education, Enforcement
