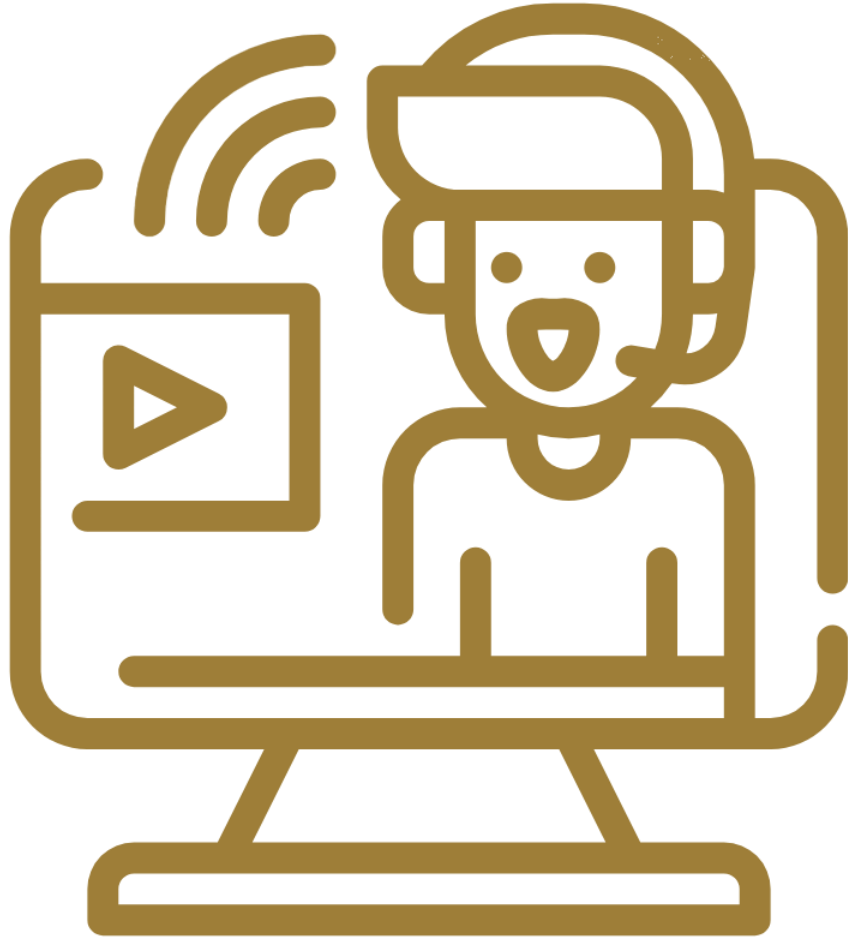

An attorney represented a first-time entrepreneur in lease negotiations with a local university for lab space. The attorney and the entrepreneur executed an engagement agreement in which the entrepreneur agreed to “waive in advance any conflict of interest that might arise in the future.”

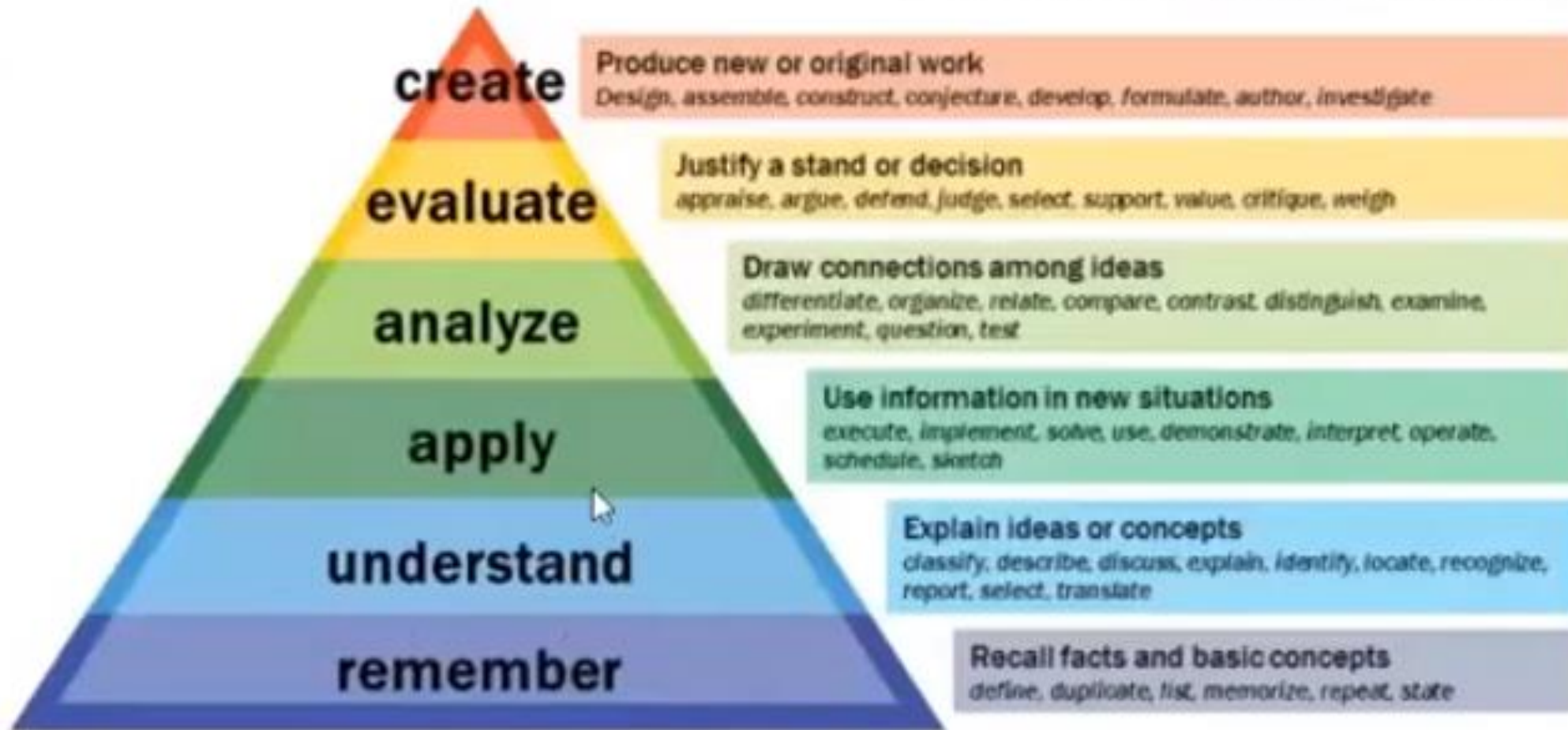
