### **ELIGIBILITY CRITERIA**

- Hold a current, active RN license within a state or territory of the United States or the professional, legally recognized equivalent in another country
- Have practiced the equivalent of 2 years full-time as a registered nurse
- Have a minimum of 2,000 hours of clinical practice in the specialty area of pediatric nursing within the last 3 years
- Have completed 30 hours of continuing education in pediatric nursing within the last 3 years

#### WHAT TO EXPECT

This certification exam is a computer-based test. This means you can apply year-round and test during a 90-day window at a time and location convenient to you. Applications for this certification will be accepted at any time.

This certification exam is made up of 150 questions (125 scored plus 25 pretest questions that are not scored). You can see the subject areas covered on the exam and the approximate number of questions in each area by reading the Test Content Outline, available at **www.nursingworld.** org/our-certifications/ The time limit for the exam is 3 hours.

### RENEWAL
