General Policies

- Information presented at the PTAP Virtual Symposium does not represent the views or standards of ANCC.
- Payment in full is required in order to process online registrations and provide access to the Virtual Symposium.
- We accept major credit card and electronic (wire and ACH) payments.
- ANCC, at its sole discretion, reserves the right to modify the PTAP Virtual Symposium.

Consent Clause

By registering and participating in activities, which includes sharing pictures with ANCC or tagging the PTAP Symposium in social media, registrant consents to the use and distribution (both now and in the future) of the registrant's image, likeness, comments, or voice in both live and on-demand reproduction of the PTAP Symposium. Attendees requested to cease harassing behavior are expected to comply immediately, and failure to comply may serve as grounds for removal from the PTAP Symposium.

When notified of individuals engaging in harassing behavior, ANCC, at its sole discretion, may take any action it deems appropriate, ranging from a simple warning to expulsion from current and/or future ANCC meetings, conferences, and events. Decisions to ban individuals from future events is the sole discretion of ANCC.

Registration Cancellation/Refund Policies

Deadline for receipt of cancellations: 11:59 p.m. EDT on April 9, 2021

- All cancellations must be submitted in writing to ptapsymp@mcievents.com and should include the registration ID number and registrant name(s).
- Cancellations will not be accepted by phone.
- Donations are **nonrefundable**.
- Full conference cancellations notice received **on or before April 9, 2021** will receive a refund less the \$25 administrative fee.
- No refunds will be issued for cancellations received **after April 9, 2021**.
- Promotions/discounts are not retroactive and cannot be applied to previously purchased individual or group registrations. Limit one special offer/discount code per registration.
- Refunds for canceled registrations are processed within four to six weeks after the close of the PTAP Virtual Symposium.
- Refunds will not be issued for “no-show” (a “no-show” occurs when a registrant does not access the live virtual event). *Note: In the event a registrant misses the live event, content will be available for 14 days post Virtual Symposium.*
- Due to processing costs, only overpayments in excess of \$25 will be considered for refunds. Please ensure that payments include the correct dollar amount to avoid overpayment.
- ANCC reserves the right to cancel or postpone any or all PTAP Virtual Symposium activities due to circumstances beyond the reasonable control of ANCC, which includes, without limitation, computer-related attacks, hacking, earthquakes, governmental regulation, fire, flood, labor difficulties, civil disorder, public health crisis, or acts of terrorism and acts of God (“Force Majeure Events”). In the event the PTAP Symposium is cancelled due to Force Majeure Events, ANCC reserves the right to either retain the entire registration fee and credit it toward a future ANCC event, or reimburse the registrant after deducting costs already incurred by ANCC, which could not be recovered from third parties.
