# Barmenia strengthens itself in caretaking with insure Health Claims from adesso insurance solutions

Dortmund, January 26th, 2017 – Just in time for the coming into effect of the changes made to the second caretaking reinforcement act (PSG II) on January 1, 217, Barmenia Krankenversicherung strengthened their digitalization strategy through caretaking components from the service billing system insure Health Claims from adesso insurance solutions GmbH.

The insure Health Claims software solution permits the automated processing of all service times from the integrated legal caretaking rates for private health insurance members who are insured completely and with aid. The vested rights protection that came into effect in the beginning of 2017 will also be considered. This reduces the complexity of billing care services and the time needed for billing will be reduced significantly.
