"Investment in the future!" The pension fund of the Hoechst Group employees renews the application landscape with adesso insurance solutions

**Dortmund, March 2, 2021-** The Pensionskasse der Mitarbeiter der Hoechst-Gruppe VVaG, one of the largest pension funds in Germany, has decided to comprehensively renew its application landscape based on products from adesso insurance solutions GmbH. Furthermore, a long-term maintenance agreement was also signed. The project has begun on March 1, 2021 and will run for approx. four years. The aim is to keep the system landscape and processes future-proof over the long term and to exploit further strategic potential in the product portfolio and digitization.

# New application landscape with in|sure products

The Pensionskasse der Mitarbeiter der Hoechst-Gruppe VVaG has a special business model for pension funds. In addition to administrating another pension fund, the Höchster Pensionskasse VVaG, its activities also include managing and administrating the company pension commitments of sponsoring companies. The new application landscape must therefore be able to illustrate the special features of the heterogeneous supply systems of the sponsoring companies. It should also be flexible with regard to the integration of new supply systems. Thanks to the new application landscape of adesso insurance solutions with components for the administration of pension fund contracts and company pension commitments, a solution for partner



administration as well as systems for statutory reporting and the accounting of pension payments, processes can be further optimized and automated in the future.

"The portfolio management system of the Pensionskasse der Mitarbeiter der Hoechst-Gruppe VVaG has so far been largely an in-house development based on SAP-HR. Triggered by SAP's announcement that it was withdrawing the existing SAP ERP HCM from maintenance, combined with uncertainty as to the extent to which functionalities for illustrating company pension schemes would still be available in the longer term, the pension fund decided to tackle the "EASy" project for reorganizing the inventory management system. "In the future, modern standard software will be used," explains Jürgen Rings, Chairman of the Board of the two pension funds based in Frankfurt-Höchst. "For the renewal of our application landscape, we have found a partner in adesso insurance solutions, who has won us over with its technical as well as its professional expertise in the bAV field and is thus optimally prepared to implement what we need and the resulting challenges."

#### adesso insurance solutions expands product range for pension funds

With the pension fund of the employees of the Hoechst Group, adesso insurance solutions won the first customer for its new product, in|sure PenPay. The already diversified product portfolio for pension funds and company pension schemes is thus expanded by adesso insurance solutions to include a settlement system for benefits from the bAV.
