

Coming July 25! New and improved suitability review forms.

You asked, we listened!

In an effort to make doing business easier while maintaining a strong suitability program, we're introducing new and improved suitability review forms in all states except Florida and New York. Our new forms have been redesigned to provide additional clarity and help you submit applications "in good order."

Check out these enhancements

Along with the enhancements shown below, the new forms request additional information up front to reduce the need for client letters and other documentation. We've also eliminated several questions that are similar in nature and asked in multiple places.

- New Rate Comparison Worksheet: This new form will be included in all
 fixed indexed annuity application packets, including electronic applications
 (e-apps). It was created to help reduce the need for additional documentation
 after the application is submitted.
- Improved Customer Identification and Suitability Confirmation
 Worksheet: There are more options to help clarify the sources of funds and
 income. We've also enhanced the Financial Section to make it easier to
 complete.
- Improved Product Comparison Worksheet: We've added questions that
 are more tailored to individual products and will help reduce the need for
 additional documentation.

Important processing dates to keep in mind...

The new and improved suitability review forms (Ver. 06/20) will be available on Athene Connect beginning **July 25, 2020** and should be used immediately.

- Applications signed on or before July 24, 2020 AND received before market close (3 p.m. CT) on August 7, 2020 will require the old forms listed above.
- Applications signed on or after July 25, 2020 OR received after market close
 (3 p.m. CT) on August 7, 2020 will require the new forms listed above.

Please note: For applications submitted on AnnuityNet or Affirm (where no sign date was provided), the application signed date is the date the electronic order is submitted to your back office for final review.

Applications with outdated or missing forms that do not fall within the guidelines listed above will be considered "not in good order." Be sure to use up-to-date materials when offering Athene annuities.
