Launch of Garfunkelux Holdco 3 S.A.'s offering of floating rate senior secured notes due 2023

Lowell ("**Lowell**"), a European leader in credit receivables management, announced today that Garfunkelux Holdco 3 S.A. (the "**Issuer**") intends to launch an offering (the "**Offering**") of €415.0 million in aggregate principal amount of floating rate senior secured notes due 2023 (the "**Notes**"). The interest rate, offering price and other terms will be determined at the time of pricing of the Offering, subject to market conditions. The proceeds from the Offering, together with cash on balance sheet, will be used to (i) redeem all of the Issuer's existing floating rate senior secured notes due 2021 (the "**Existing 2021 Euro Notes**"), (ii) pay the accrued interest and the redemption premium for the Existing 2021 Euro Notes and (iii) pay fees and expenses in connection with the Offering and the foregoing. There can be no assurance that the Offering will be completed.
