Access to Off-Duty Insurance Alleviates Concerns

When jobs are invoiced and paid through the platform, the department, business and officer gain access to RollKall's three insurance options*: Workers' comp, general liability and occupational accident insurance.

Taking advantage of RollKall's insurance options acts as a first line of defense, ensuring coverage while preventing a claim from hitting the agency or governmental policy.

- ✓ **General Liability:** Up to \$1 million per occurrence, protecting the business owner and assets in the event of legal action against the business or its employees. It also covers medical costs if a customer or employee is injured during an incident.
- ✓ **Workers' Compensation:** Provides the officer with lost wages protecting both off-duty and on-duty wages. It also covers medical costs if an officer is injured while conducting off-duty work.
- ✓ **Occupational Accident Insurance:** Protects the officer by covering medical costs as well as death and dismemberment.
