Nasal Flu Vaccine NOT Recommended for 2016/2017 Season

The CDC's Advisory Committee on Immunization Practices (ACIP) voted that the intranasal influenza vaccine not be used during the 2016/2017 flu season. This nasal spray vaccine is the live attenuated influenza vaccine (LAIV). The vote was based on data from 2013-2016 that showed poor or lowered effectiveness of the vaccine. The annual flu vaccination, with either the inactivated influenza vaccine (IIV) or recombinant influenza vaccine (RIV), is still recommended by the ACIP for everyone 6 months and older. Olanzapine Warning-Life Threatening Reaction

The FDA is adding new warning labels to all products containing the antipsychotic olanzapine to inform patients and providers about the risk of causing a rare but life threatening skin reaction. This condition is known as Drug Reaction with Eosinophilia and Systemic Symptoms (DRESS). Symptoms include a rash, swollen lymph nodes, and swollen face. Eosinophilia occurs causing inflammation and swelling which may result in injury to vital organs such as the liver, kidneys, lungs, pancreas, or the heart. The mortality rate from DRESS is up to 10%. Olanzapine products include Zyprexa, Zyprexa Zydis, Zyprexa Relprevv, and Symbyax, and also as generics. Educate caregivers to observe for symptoms of DRESS and to seek medical care immediately if DRESS is suspected. Aripiprazole Warning-Impulse Control Reports

Compulsive and uncontrollable urges to gamble, shop, binge eat, and engage in sexual activity with the use of the antipsychotic drug aripiprazole have been reported to the FDA. Aripiprazole products include Abilify, Abilify Maintena, Aristada, and generics. When the medication was discontinued or the dose was reduced the uncontrollable urges were reported to have stopped. The reports of impulse-control are rare, but if not recognized may result in harm to the patient and others. Encourage caregivers to closely monitor individuals for new or worsening uncontrollable urges while being treated with this medication. Assisting physicians in providing quality health care to people with intellectual disabilities is an honor for nurses working in this special field of nursing. Be an advocate and consider forwarding this website to physicians. Better yet, download the forms of interest, such as the male and female checklists or the health watch tables for a specific genetic syndrome and provide them to the physician at the next appointment. Supply them to the physician at the next appointment and explain that the forms can be downloaded electronically for continued documentation at future appointments.
