RE: SUD Waiver Residential Adult Services Treatment Rates

The Bureau for Medical Services (BMS) is pleased to announce the interim reimbursement rates for Adult Residential Treatment Services, based on ASAM® criteria. It is anticipated that these rates will be in effect for approximately eighteen (18) months, beginning July 1, 2018. The following are the billing codes and per diem rates for each ASAM® level:

- **ASAM® Level 3.1, Procedure Code: H2036U1HF = \$175**
- **ASAM® Level 3.3, Procedure Code: H2036U3HF = \$225**
- **ASAM® Level 3.5, Procedure Code: H2036U5HF = \$225**
- **ASAM® Level 3.7, Procedure Code: H2036U7HF =**
  - *For **existing hospital-based** providers (existing sub-acute units located in a hospital setting), there is no proposed change to existing rates.*
  - *For **new hospital-based** providers (new sub-acute units located in a hospital setting), an interim rate will be based on current methodology for this provider type.*
  - *For **new non-hospital-based** providers (non-hospital providers), rates will be developed in the future.*

These new services are part of the ongoing effort to provide a continuum of care designed to treat substance use issues among the state's Medicaid population. More information on these services will be released soon in the July 1, 2018 version of the West Virginia Provider Manual Chapter 504, Substance Use Disorder Services.

To be reimbursed for Residential Adult Services, all new and existing Residential Treatment Programs must be enrolled as Medicaid Providers and must be approved by BMS before rendering services. The application in **Chapter 504, Appendix B Application for Residential Adult Services** must be completed and submitted to BMS at [BMSSUDWaiver@wv.gov](mailto:BMSSUDWaiver@wv.gov)

BMS will review the application within 30 days of receipt and will notify the provider of approval, denial, or request more information. The certification is good for two years from the date of approval. BMS reserves the right to terminate certification due to non-compliance of policy, state licensing revocation, or reports of abuse, fraud, or other issues that are indicative of improper practice.
