# THE OPALESCENCE GLOBAL SELFIE CHALLENGE

The Opalescence Global Selfie Challenge (the "Contest") is sponsored by Ultradent Products, Inc. ("Ultradent"). By participating in the Contest, each Entrant (defined below) agrees to abide by these terms and conditions, including, without limitation, all eligibility requirements (collectively, the "Official Rules"). Each Entrant understands that the results of the Contest, as determined by Ultradent and its agents, are final in all respects. This is an irrevocable condition of entry.

The Contest is subject to all federal, state, and local laws and regulations and is null and void where prohibited by law.

## **CONTEST OVERVIEW**

To participate in the Contest, an Entrant must (i) during the Submission Time Period (defined below), post to their Facebook or Instagram account a picture of the Entrant smiling; (ii) tag Opalescence in their post (@opalescence on Facebook or @opalescencewhitening on Instagram); and (iii) post in the caption the hashtag #Opalescencechallenge (collectively, the "Posts").

Within seven (7) days after the end of each month during the Submission Time Period, Ultradent will randomly select one monthly winner from all eligible entries. There is no limit on the number of times an Entrant may enter; provided, however, that each Post must tag Opalesence, as set forth above, and an Entrant may only win one (1) time during the Submission Time Period.

## **ELIGIBLITY**

To be eligible to participate in the Contest, the Entrant must (i) be eighteen (18) years of age or older at the time of entry; (ii) be a legal resident of United States of America; and (iii) have otherwise complied with the Official Rules set forth herein (the "Entrant"). No purchase or payment of any kind is necessary to enter or to win. Ultradent has the right to verify eligibility of each Entrant. ## CONTEST TIME PERIOD

The Contest begins on July 1, 2021 at 12:01am Mountain Time and ends on June 30, 2022 at 11:59pm Mountain Time (the "Submission Time Period"). All Posts must be received during the applicable month during the Submission Time Period to be eligible for that month's prize. Ultradent is not responsible for lost, late, or misdirected entries, server unavailability, computer, or any other electronic malfunction. Ultradent reserves the right to extend or shorten the Contest in its sole discretion.

#### WINNER SELECTION

One (1) winner will be randomly selected each month during the Submission Time Period from all eligible entries. The winner will be notified within seven (7) business days after the end of the applicable month by direct message on the platform that the winner used to submit the Post. The winner must confirm acceptance of the prize by contacting Ultradent within no later than seventy-two hours (72) hours after the date on which Ultradent first notifies the winner. The winner must execute and return any required affidavit of eligibility, release of liability, publicity release, and/or prize acceptance form within ten (10) days of receipt of such documentation from Ultradent. In the event the winner cannot be contacted, does not confirm acceptance within seventy-two (72) hours, or does not timely sign and return any required documentation, then the winner shall forfeit the prize and another winner may be selected.
