

The ObjectVault cloud system then returns a 180 character alphanumeric password which is optically encoded and shareable.

#### **Security Details**

- Time-limited access code duration is controlled by the site
- Access code can provide up to 1000 years of security
- Option to require patient DOB (2nd factor authentication)
- The patient controls who can access their PHI

- 180 character alphanumeric optically coded password
- Web interface leaves no PHI on accessing device
- All information transferred through SSL (encrypted in transit as well as at rest)
