1. There is a need to determine why 3970 students with 2022 ISIRs were not assigned the FTE 'Thank You' email while 4340 letter code/email were processed with Instance 6779894 that didn't get one and 10919210 who did
2. Worked with Teresa/Charin to figure out why the 3CEngine process is not assigning the FTE Letter Code for 3970 students - No resolution yet We tried with a new run control. An urgent meeting is required with Richard, Roderick and Charin to figure this out! Because we have 3970 students that have sent in an ISIR we have not acknowledged
3. There appears to be something wrong with the system processing – Why, for example, weren't all the checklists assigned during the first process and why weren't all the letter codes assigned ?? ID 11087486 is an example of student that did not get letter code assigned
4. The immediate goal is to complete summer packaging
5. There are 3408 students with summer 2021 FA Term. But **summer budgets are not built** – Why aren't summer budgets being built?
6. Hemanth and I have pieced together the 'as is' process to administer the CCPG/BOG Waiver. The manual process must continue for now until we have time to work on it
7. Roderick can go ahead and schedule the Job PCCFA3CS for the 3Cs steps only and add to it the Ability to Benefit PCCFA017 and just the 3C Engine run control PCCFA\_FTE followed by the CommGen process run control PCCFA\_FTE

### FA Processing 6-14-21

Topics for discussion:

**Top Priority** is Summer Packaging – Need to award and disburse Pell prior to Thursday June 17th

1. Resolved – Charin proposed fix that worked. By removing the duplicate communications check box, FTE (Thank you) letter codes were assigned and subsequently sent to students with the CommGen process
2. Roderick is now running a scheduled job daily to assign checklists, process ATB (Ability to Benefit), Assign and send the Thank You email. Once tested, the NSLDS request and User Edit Messages will be added to this daily process

2. The Mass Packaging for Summer will be processed as a separate Job. However, the initial live mode will be done manually by Richard after testing in simulation

4. An email was sent to each FAO requesting a review and confirmation of the results. Richard reviewed the simulation results with each college. Agreement was reached that

the Pell amounts were correct with one exception: Seven students with a Pell amount of \$793 seem to have a previously recognized problem with the <1/2 Time Pell COA. It was decided to remove them from the packaging until resolution is reached. This is supported by Loan who mentioned it was an issue in prior terms that required manual intervention

5. Note – All FAOs express concern that the number of students selected for summer mass packaging seems low compared to students enrolled for summer. This needs a detailed review of the selection criteria dictating eligibility requirements
6. Hemanth to update the SEOG, CARES HEERF awarding, etc.
