This document compares the Peralta CCD Board Self-Evaluation Spring 2020 to Spring 2021 based on ACCJC Standards. While there is room for improvement, there is a strong increase in Board members feeling the standards are met on every question, other than those already at 100% (questions 6 and 16)

Please note that in Spring 2020 5 trustees responded (one less on the last question) Spring 2021 6 trustees responded (one less on the last question).
