District Regional Funds – reallocation

- I. Welcome and Introductions
 - a. SWF Webinar 2-3 PM
- II. Perkins V
 - a. Extension to June 5th: Where do we stand on colleges receiving data updates from the District?
 - Need for some district-wide discussion. (State is not organized; facing new territory, too.) Submission needs to be made by the district. Therefore, a meeting set for Monday to clarify information for all parties. Alignment across the colleges has yet to be completed.
 - 1. AVC of IR, De Doan, to be included in meeting to know what will be needed from his department
 - 2. Look for clarity at Monday meeting
 - ii. Change from Perkins IV to V: more outcomes-driven, serving different populations.
 - 1. Helpful to become familiar with Perkins V.
 - 2. Had 1-year prior knowledge that Perkins V would be changed, but was never informed submission of document was necessary.
- III. District Regional Funds Reallocation
 - a. Basic needs for Fall: PPE, other supplies, Chromebooks, faculty stipends to conduct training on hygiene protocol and other areas; discussion on using the district regional fund as this applies to all colleges
 - i. Not ideal to pay some faculty stipends others none
 - ii. Not required to conduct summer training
 - iii. PPE is viable; other funds can be used for this. Must check with VC Sata; PCCD is ordering PPE anyway, but needs more detail.
 - 1. Example: at Laney, hand sanitizer, 2K masks for students (loose handkerchief mask is not safe for machinery), equipment wipes, gloves, thermometers ordered for 5 departments for 3 weeks
 - 2. Get a sense of how much will be needed based on how fall course offerings are, including comments/bullet points
 - a. Find out what's being ordered, what funds are being used

- 3. Are any funds available for virus protection in labs? Yes. CARES Act funds and FEMA funds. Next meeting: invite VC Sata and Royal Roberts to discuss safety and risk.
- iv. Have unspent regional funds available. Can it be used for PPE as district requirement? As well as remaining funds from Round 3 and new pot for Round
 - 1. Want these funds to go back to colleges. Find an alternative use for funds, ensure the big picture is being considered.
- v. ACTION ITEM: Must respond to BACCC for actual allocation for Round 4. Be clear about the dollar amount.
 - Motion to approve the allocation to the district as originally determined (\$365K) and the remaining balance to the colleges based on CTE FTES, and continue to discuss how the funds are used at the district level. For Round 4. (Challenge is that we never went through process of confirming what the allocation are for the regional component. The local allocation was clear.)
 - a. Jennifer Briffa seconds.
 - b. Discussion: See VC Brown's Excel Sheet District Allocation.
 - i. If colleges' funds are less (\$-250K approx.), why aren't district funds less?
 - c. 5 Yes, 2 Nos, Motion carries
- IV. Dual Enrollment: Where do we stand
 - a. DE is still on for the fall with the biggest partners. Building in extra support for students: high school teacher can have access to the course shell
 - b. C CAP with Albany, Berkeley Unified
