COA Library Resources Curbside Pick Up

Since late spring semester when CoA received its first shipment of Chromebooks the library staff and faculty have been working with the administration to check out computers for student use. At the start of the fall semester CoA's library was the first in the district to roll out curbside distribution of library resources. Staff are coming in 3 days a week and we've checked out nearly 100 Chromebooks to students so far. We're also distributing calculators and circulating books. For more details

CoA Answers the CCCO's Call to Action

In early summer, in response to the nationwide outcry against the murders of George Floyd, Ahmaud Aubrey, Breonna Taylor, and so many others, California Community Colleges Chancellor Eloy Ortiz Oakley and system leaders called on us to actively strategize and take action against structural racism. Over the course of the summer CoA campus community members began a variety of conversations around these topics. The CoA President's Office is continuing these conversations with a series of informal virtual meetings. At the most recent campus dialog, on October 8, 2020, participants discussed the CCCO's third Call to Action topic on community colleges auditing classroom climate and creating an action plan to ensure that classrooms are inclusive and that colleges offer anti-racism curriculum. College of Alameda faculty, staff, and administrators have participated in a wide variety of trainings on this subject, most recently with approximately 50 campus community members training at the Equity Institute on creating transformational courses to serve students of color and build anti-racist curriculum, as well as training on counseling in the era of equity. CoA faculty and senate leadership have been active participants and are addressing these issues directly in the classroom. CoA's Call to Action dialogs will continue this month.
