Unit-Dose Repackaging Services

Safecor Health's unit-dose repackaging services help institutional pharmacies improve pharmacy operations while simultaneously reducing drug and packaging costs.

By leveraging a Safecor Health repackaging relationship, pharmacies can strategically purchase bulk products, on-contract, through their pharmaceutical wholesaler at the lowest cost-per-dose prices (GPO/WAC/340B) and have the products repackaged and bar-coded into unit-dose, ready to dispense.

Unit-Dose Oral Solids

Safecor Health's oral solid unit-dose packaging provides a range of packaging options, including unit-dose strips and robot-compatible packaging.





Liquid Unit-Dose Cups

Safecor Health's liquid unit-dose cups deliver an accurate dose to the patient and are available in hospital-specified dose and multiple cup sizes.

Available cup sizes: 15 mL, 25 mL and 35 mL

Oral Syringes

Safecor Health's unit-dose oral syringes include a bar-coded flag label and tamper-evident overwrap bag that is also labeled and bar-coded. Our amber oral syringes are available in several sizes ranging from 0.5 mL to 20 mL.



Available syringe sizes: 0.5 mL, 1 mL, 3 mL, 6 mL, 12 mL and 20 mL



ENFit Syringes

Safecor Health's services include repackaging medications in NeoMed ENFit syringes.

Available ENFit syringe sizes include 0.5 mL, 1 mL, 3 mL, 6 mL, 12 mL, 20 mL and 35 mL with your desired dose size and bar code.

Purple ENFit tamper-evident caps are also available upon request for controlled substances.

Bar Coding and Labeling

Safecor Health's flexible bar coding helps hospitals increase patient safety initiatives and are available in multiple formats, including linear and 2D Datamatrix. Safecor Health bar code formats and content are designed to work with all pharmacy systems.



Safecor Health's drug labels follow FDA and ISMP guidelines and are standardized to generally include:

- Generic drug name (TALLman lettering)
- Brand drug name (if applicable)
- Strength
- Alcohol % (liquids)
- Lot #
- Expiration date
- Manufacturer

- Bar code
- "Repackaged by Safecor Health," as required by the FDA
- "Hazardous," if on the NIOSH list
- "Refrigerated," if original manufacturer's bottle states it requires refrigeration
- "Rx" or "Rx Only," if medication requires a prescription

Controlled Substances

Safecor Health repackages most C-II and C-III through V oral solid and liquid medications into unit-dose to deliver the lowest cost-per-dose in unit-dose for institutional pharmacies. Repackaging controlled substances with Safecor Health helps address regulatory compliance and the increased packaging risks associated with controlled substances.

Hazardous Drugs

Safecor Health addresses the USP <800> packaging needs of institutional pharmacies by repackaging many hazardous drugs on the NIOSH list.



Robot Packaging

Safecor Health offers robot-compatible packaging, robot bar codes and robot overwraps. Repackaged robot medications come on a cardboard tube to facilitate robot replenishment.



RFID Tagging

RFID tags allow hospitals to reduce the time and error associated with manually restocking pharmacy kits and anesthesia trays. Safecor Health provides RFID tagging services for specific vendors (ex. Kit Check) so that fast-moving products arrive at your institution pre-tagged and ready to replenish into specific kits via the vendor's software.



340B Hospitals

Safecor Health supports the unit-dose repackaging of 340B purchases for Covered Entities (hospitals) through their wholesaler via 340B/GPO/WAC bill to/ship to ordering accounts that are integrated into a hospital's existing split-billing system and accumulators.

Respiratory

Safecor Health supports the unique handling and dating requirements of various respiratory medications and provides a unit-dose package with a bar code in flag-label or over-bag formats.

Commercial Unit-Dose Products

Safecor Health offers an expanding portfolio of unit-dose medications to further assist with institutional pharmacies' unit-dose needs. The commercial products are all manufactured in the U.S. by firms registered with and inspected by the U.S. Food and Drug Administration (FDA), providing the highest-quality products.

Safecor Health's commercial unit-dose products are on contract with most acute-care GPOs and can be ordered through your normal wholesaler account. If your local distribution center doesn't have a specific unit-dose item in stock, pharmacies can submit a stocking request form to their wholesaler and local distribution center.
